**NOTIFICATION**

In exercise of the powers conferred by rule 13 of Sikkim Chief Electrical Inspector and Electrical Inspector (Qualifications, Powers & Functions) Rules, 2017, the state Government hereby, with immediate effect, notifies that the fee payable for Testing & Inspection of electrical installations and services by Inspectors or any other officer appointed to assist him shall be as specified in schedule given below, namely:-

**NOTE:**

- (1) For the testing and inspection of Temporary Installation/Connection, 50% of the actual fee shall be payable which shall be valid for two months. After the initial inspection, re-inspection shall be carried out on monthly basis for which 50 % of the actual fee shall be payable for each re-inspection.

- (2) For every re-testing and re-inspection carried out due to breach of any of the provisions of the Electricity Act 2003 and Central Electricity Authority Regulations, 2010 or rules and regulations made there under , 50% of the previous testing and inspection fee shall be payable.
- (3) The Fees prescribed above shall be payable for each periodical inspection and testing as per the frequency of inspection and testing prescribed by the state government from time to time.
- (4) The fee of inspection and testing of electric installations carried out by Chartered Electrical Safety Engineer shall be paid by the owner or his agent to the Chartered Electrical Safety Engineer.
- (5) The fee for inspection and testing of installations carried out by the Electrical Inspectors or any other officer appointed to assist him shall be paid by the owner or his agent to be deposited in the Government head of account and the receipt of payment to be produced to the office of Electrical Inspectorate.
- (6) The above fee specified in the schedule shall be increased further by 10% after every three years from the date of issuance of this notification.
- (7) Any other fee as the Chief Electrical inspector may deem proper and reasonable in the circumstances shall be levied if necessary.
